

Carnaghi Productions Service Agreement



This is a general agreement between Tony Carnaghi, owner and sole proprietor of Carnaghi Productions and:

This agreement is for the production of a Professional Voice Over Demo whereby the Owner/Operator of Carnaghi Productions, Tony Carnaghi, will record, edit, master and otherwise produce the highest quality audio demo possible by use of their own in house Studio Recording Equipment for the booking client named above at a rate of: (See Attached Rate Sheet).

The rate for service of \$ _____ USD, as chosen by the client per the attached rate sheet, includes Studio time, use of Professional Studio Recording Equipment any Royalty Free Media such as Sound Effects and Music necessary to produce an industry standard product required for finalizing the project as promised.

The final Commercial Demo will be longer than sixty (60) seconds but no longer than one minute thirty seconds (1:30) as preferred by the Voice Over industry as an acceptable length of time for such a demo.

Additional responsibilities of the Studio may also include:

1. Securing a deposit for services of \$ _____
2. Collecting the balance of outstanding funds before providing the client with the final product.
3. Make accessible to the client written material for use on the demo.
4. Copy writing of original commercial scripts whenever necessary.
5. Provide Artistic Direction on how the client should interpret the written copy in order to produce the best sounding recorded take during the session.
6. Allowing the client an opportunity for one (1) revision to make minor adjustments as may be necessary.

Carnaghi Productions, Tony Carnaghi, their partners and affiliates are not directly or indirectly responsible for the individual client's ability to perform in the studio during a recording session at any given time.

The above named client holds Carnaghi Productions, Tony Carnaghi, their partners and affiliates harmless from any unforeseen circumstances that may be out of the control of the hired studio, Carnaghi Productions, to complete the project within a timely manner as agreed.

Should the above named client be dissatisfied with the end product after proofing the product and making any minor adjustments as requested; additional hours for re-recording and mastering a new Demo will result in additional hourly booking fees at rate of: (See Supplemental Rate Sheet Attached)

This agreement for services is in no way a guarantee of work in the Voice Over Industry and the finished demo is only intended to be used as reference of the client's abilities to perform as a Voice Artist for demonstration purposes only.

Acceptable uses for a commercial demo include but may not be limited to:

1. CD distribution to Agents, Casting Directors and potential clients.
2. Posting on various websites that are targeted for securing auditions of Voice Over jobs.
3. Posting on the clients own website for demonstration purposes.
4. Listing on any web based directory specific to the Voice Over community in whole or in part thereof.
